

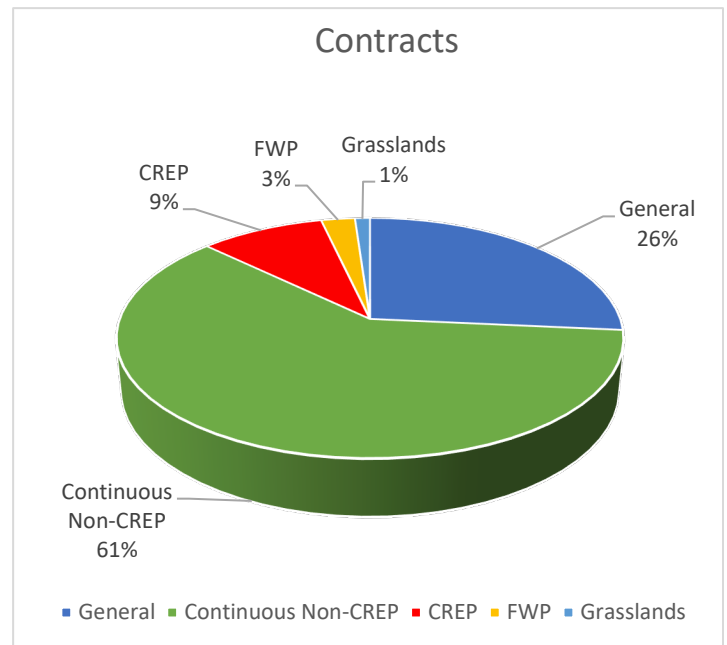
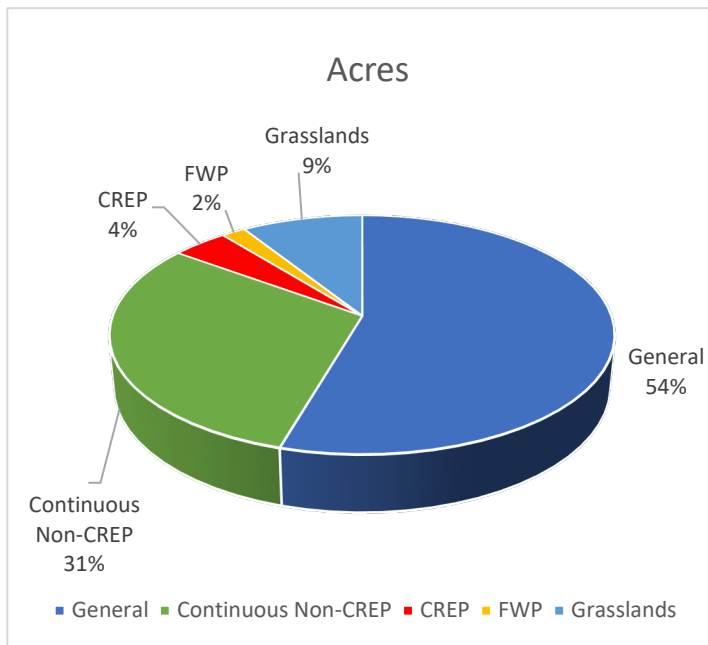

**General Signup.** Producers with eligible lands compete nationally for acceptance based on an environmental benefits index (EBI) during specified enrollment periods. Producers may submit offers below soil-specific maximum rental rates and select wildlife-enhancing vegetative covers to increase EBI ranking.

**Continuous (Non-CREP) Sign-up.** Producers with eligible lands may enroll certain high priority conservation practices, such as filter strips, riparian buffers, and wetlands at any time during the year without competition. In addition to annual soil rental payment and cost-share assistance, many practices are eligible for additional annual and one-time up-front financial incentives.

**Conservation Reserve Enhancement Program (CREP).** Under CREP, federal funds are supplemented with non-federal funds from eligible partners to implement projects designed to address specific environmental objectives through targeted CRP enrollment. Eligible partners provide matching contributions such as cash, in-kind contributions, or technical assistance. Eligible producers may enroll eligible land any time during the year.

**Farmable Wetland Program (FWP).** Producers enroll small non-flood plain wetlands, and new practices added by the 2008 Farm Bill, under modified continuous sign-up provisions.

**Grasslands.** Enrollments are to support grazing operations and to preserve and restore grasslands. No cropping history is required.

The accompanying tables are based on contract data developed and maintained in CRP data files by USDA Service Centers through the **end of April** and are based on the physical location of the CRP contracted land. Some adjustments have been made to correct miscoded data in the active contract files.

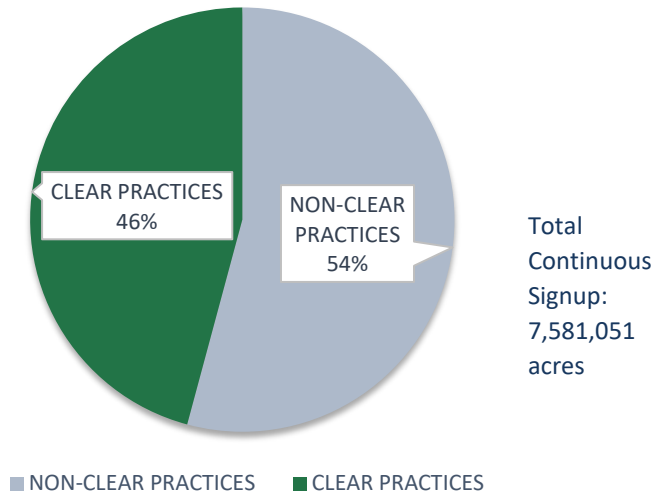

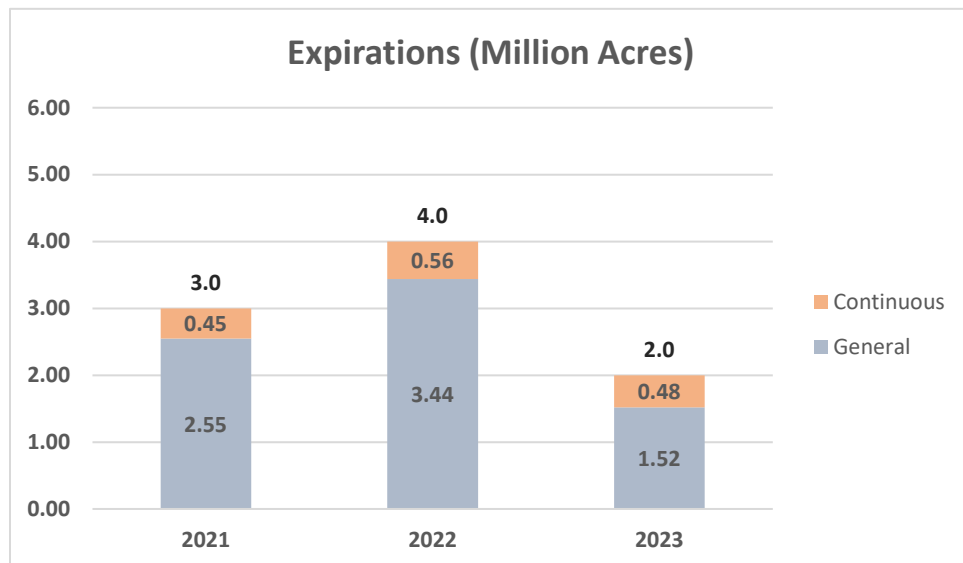

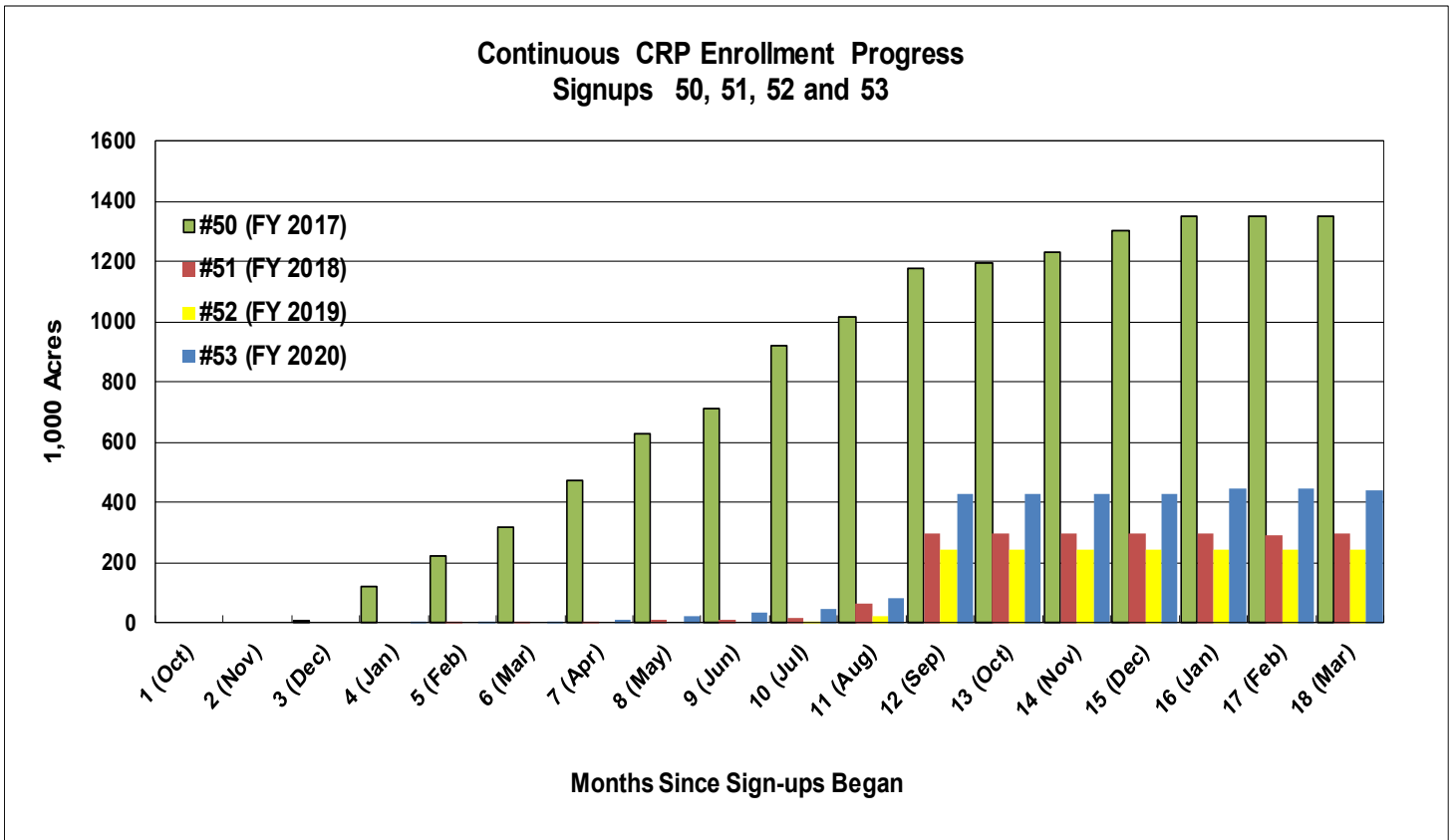

# CONSERVATION RESERVE PROGRAM

## ENROLLMENT ACTIVITY AND NEWS – APRIL 2021

- Enrollment ends April 2021 at 20.8 million acres, same as March.
- FY 2021 continuous (#55) signup opened October 1.
- Updated soil rental rates for FY 2021 were posted and went into effect December 1, 2020.
- On April 21, 2021, Secretary Vilsack announced that USDA will open enrollment in CRP with higher payment rates, new incentives, and a more targeted focus on the program’s role in climate change mitigation. These changes will go into effect mid-June 2021.
- General signup (#56) opened on January 4, 2021 and is open until further notice.
- The next grassland signup will open after the General signup concludes. Date to be determined.
- A new signup period for the Soil Health and Income Protection Program (SHIPP) is currently open from May 10 through July 16, 2021.



Signups 55 and 400 currently at 21,541 acres.
