

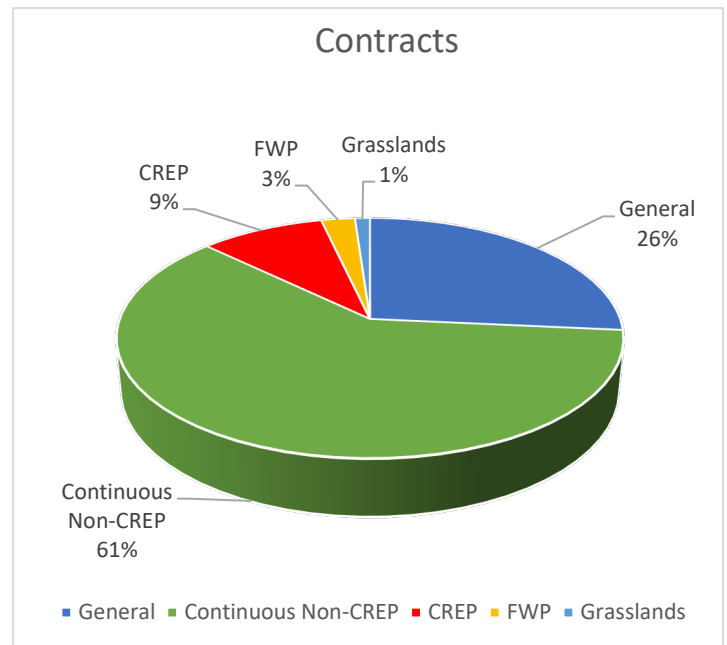
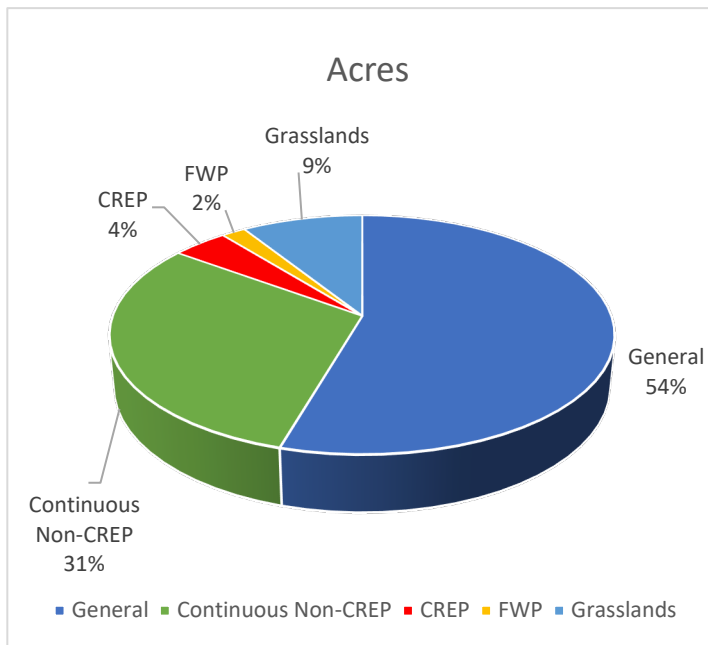

General Signup. Producers with eligible lands compete nationally for acceptance based on an environmental benefits index (EBI) during specified enrollment periods. Producers may submit offers below soil-specific maximum rental rates and select wildlife-enhancing vegetative covers to increase EBI ranking.

Continuous (Non-CREP) Sign-up. Producers with eligible lands may enroll certain high priority conservation practices, such as filter strips, riparian buffers, and wetlands at any time during the year without competition. In addition to annual soil rental payment and cost-share assistance, many practices are eligible for additional annual and one-time up-front financial incentives.

Conservation Reserve Enhancement Program (CREP). Under CREP, federal funds are supplemented with non-federal funds from eligible partners to implement projects designed to address specific environmental objectives through targeted CRP enrollment. Eligible partners provide matching contributions such as cash, in-kind contributions, or technical assistance. Eligible producers may enroll eligible land any time during the year.

Farmable Wetland Program (FWP). Producers enroll small non-flood plain wetlands, and new practices added by the 2008 Farm Bill, under modified continuous sign-up provisions.

Grasslands. Enrollments are to support grazing operations and to preserve and restore grasslands. No cropping history is required.

The accompanying tables are based on contract data developed and maintained in CRP data files by USDA Service Centers through the **end of March** and are based on the physical location of the CRP contracted land. Some adjustments have been made to correct miscoded data in the active contract files.

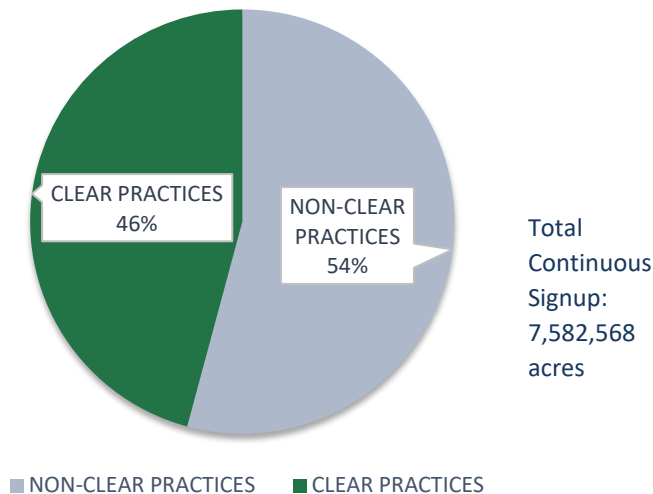

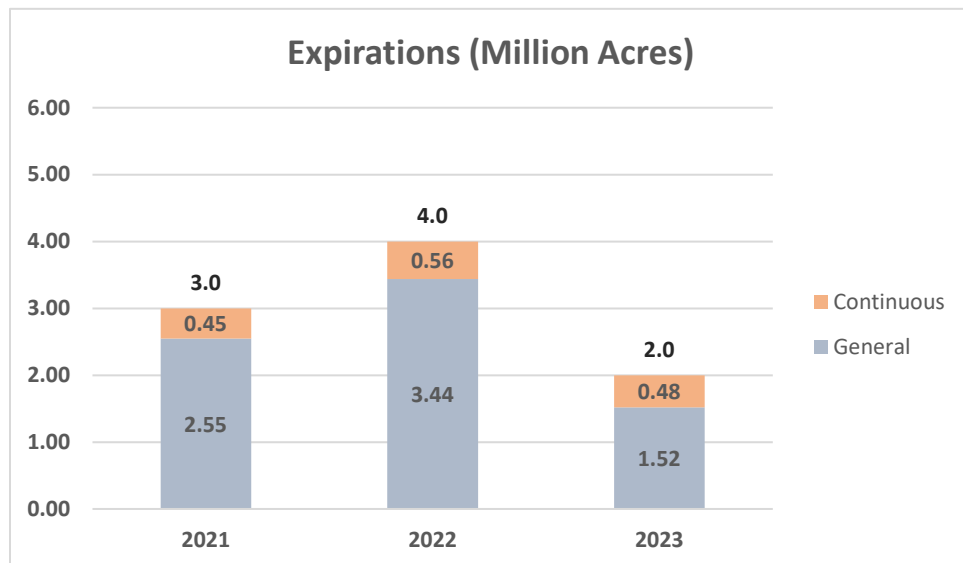

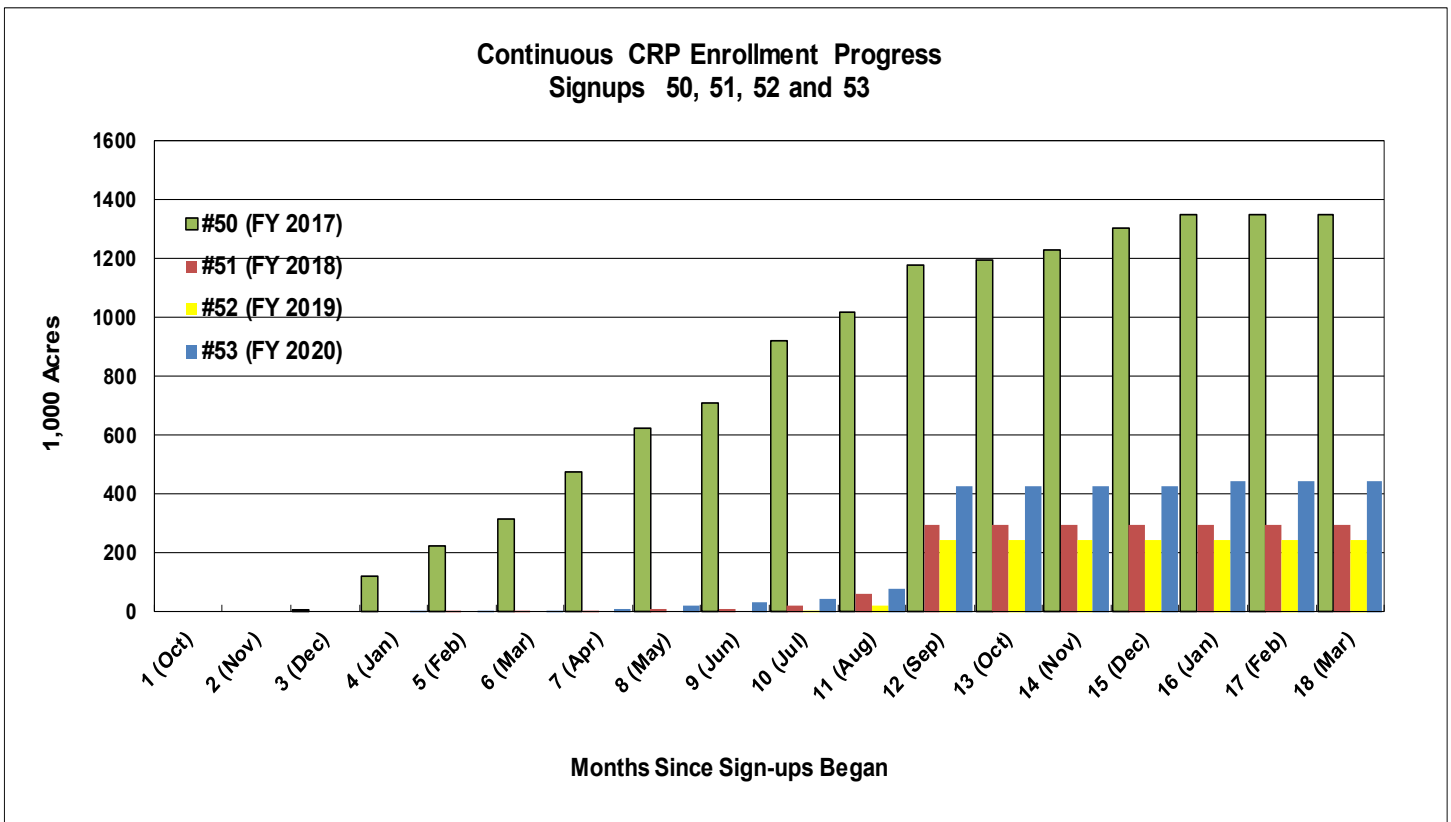

CONSERVATION RESERVE PROGRAM

ENROLLMENT ACTIVITY AND NEWS – MARCH 2021

- Enrollment ends March 2021 at 20.8 million acres, same as February.
- FY 2021 continuous (#55) signup opened October 1.
- Updated soil rental rates for FY 2021 were posted and went into effect December 1, 2020.
- Incentives increased for continuous signup December 9.
- General signup (#56) opened on January 4, 2021 and is open until further notice.
- The next grassland signup will open after the General signup concludes. Date to be determined.
- On April 29, 2020 the new pilot program CLEAR 30 signup was announced. Signup began July 8 and ran through August 21. It was available to producers with expiring CLEAR eligible (water quality) expiring contract practices in the Chesapeake Bay and Great Lakes states. Contracts will be for 30 years.



Signups 55 and 400 currently at 17,591 acres.
