Program Announcement

PREVAILING WORLD PRICES AND LOAN DEFICIENCY PAYMENT RATES

WASHINGTON, February 4, 2015-The Department of Agriculture's Commodity Credit Corporation today announced the following prevailing world market prices of milled and rough rice, adjusted for U.S. milling yields and location, and the resulting marketing loan gain (MLG) and loan deficiency payment (LDP) rates applicable to the 2014 crop, which will become effective today at 7:00 a.m., Eastern Time (ET). Rough rice prices decreased \$0.04 per cwt for long grain and \$0.17 per cwt for medium/short grain. The changes in the announced prices and rates reflect world market prices and technical changes due to the milling yield information available for the 2014 crop.
