Each office shall be responsible for:

- reviewing the respective contract and contacting the vendor to arrange for court reporting services
- issuing orders and making payment through purchase card procedures
- following the instructions in 27-AS when:
 - placing orders
 - resolving minor discrepancies with the contractor
 - processing invoices for payment, including assessing liquidated damages when necessary.

B Effective Date

The contracts have been awarded for the base period beginning October 1, 2001, through September 30, 2002, with 4 option years, bringing the total period of performance through September 30, 2006.
