USDA Announces Availability of Low-Interest Physical Loss Loans for Producers in Minnesota Affected by Flooding, Excessive Rain, High Winds, Hail, and a Tornado

<u>Physical loss loans</u> through the United States Department of Agriculture's (USDA) Farm Service Agency (FSA) can help producers repair or replace damaged or destroyed physical property essential to the success of the agricultural operation, including livestock losses. Examples of property commonly affected include essential farm buildings, fixtures to real estate, equipment, livestock, perennial crops, fruit and nut bearing trees, and harvested or stored crops and hay.

Impacted Area: Minnesota

<u>Triggering Disaster 1</u>: N1754 for Flooding, Excessive Rain, and Flash Flooding from June 1, 2024, and continuing.

Application Deadline: March 12, 2025

<u>Primary Counties Eligible</u>: Blue Earth, Cottonwood, Fillmore, Goodhue, Jackson, Le Sueur, Martin, Murray, Nicollet, Nobles, Pipestone, Rice, Rock, St. Louis

Contiguous Counties Also Eligible:

Application Deadline: March 10, 2025

Primary Counties Eligible: Lincoln

Minnesota: Lyon, Pipestone, Yellow Medicine

South Dakota: Brookings, Deuel, Moody
