Thirty Counties in Kentucky Declared a Primary Natural Disaster Area Due to Drought, With Additional Counties in Kentucky, Indiana and Ohio Eligible as Contiguous Counties

This Secretarial natural disaster designation allows the United States Department of Agriculture (USDA) Farm Service Agency (FSA) to extend much-needed emergency credit to farm operators in primary counties and contiguous counties through FSA <u>emergency loan</u> assistance. Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation, or to refinance certain debts. FSA will review the loans based on the extent of losses, security available, and repayment ability. The deadline for producers in designated primary and contiguous counties to apply for loans is June 16, 2025.

According to the <u>U.S. Drought Monitor</u>, these counties suffered from a drought intensity value during the growing season of 1) D2 Drought-Severe for eight or more consecutive weeks or 2) D3 Drought-Extreme or D4 Drought-Exceptional.

Impacted Area: Kentucky, Indiana, and Ohio

Triggering Disaster: Drought

Application Deadline: June 30, 2025

Primary Counties Eligible:

Kentucky – Anderson, Bath, Boone, Boyle, Bracken, Campbell, Carroll, Clark, Fayette, Fleming, Franklin, Gallatin, Grant, Harrison, Henry, Jessamine, Kenton, Mason, Menifee, Mercer, Montgomery, Oldham, Owen, Pendleton, Powell, Robertson, Scott, Trimble, Washington and Woodford Counties.

Contiguous Counties Also Eligible:

Indiana – Clark, Dearborn, Jefferson, Ohio, and Switzerland Counties.

Kentucky – Bourbon, Casey, Estill, Garrard, Jefferson, Lee, Lewis, Lincoln, Madison, Marion, Morgan, Nelson, Nicholas, Rowan, Shelby, Spencer and Wolfe Counties.

Ohio - Adams, Brown, Clermont and Hamilton Counties.
