

# USDA Designates 24 Texas Counties as Primary Natural Disaster Areas for Drought (Fast-Track)

**Emergency Designation | Texas | November 21, 2024**

This Secretarial natural disaster designation allows the United States Department of Agriculture (USDA) Farm Service Agency (FSA) to extend much-needed emergency credit to producers recovering from natural disasters through [emergency loans](#). Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation, or to refinance certain debts. FSA will review the loans based on the extent of losses, security available, and repayment ability.

According to the [U.S. Drought Monitor](#), these counties suffered from a drought intensity value during the growing season of 1) D2 Drought-Severe for eight or more consecutive weeks or 2) D3 Drought-Extreme or D4 Drought-Exceptional.

**Impacted Area:** Texas

**Triggering Disaster 1:** Drought (Fast-Track) occurring September 17, 2024, and continuing.

**Application Deadline:** May 23, 2025

**Primary Counties Eligible:** Archer, Cottle, Foard, Hall, Hemphill, King, Lipscomb, and Wichita

**Triggering Disaster 2:** Drought (Fast-Track) occurring August 13, 2024, and continuing.

**Application Deadline:** June 9, 2025

**Primary Counties Eligible:** Briscoe, Collingsworth, Fannin, and Motley

**Triggering Disaster 3:** Drought (Fast-Track) occurring October 8, 2024, and continuing.

**Application Deadline:** June 16, 2025

**Primary Counties Eligible:** Grayson and Lamar

**Contiguous Counties Also Eligible:** Collin, Cooke, Delta, Denton, Fannin, and Red River

**Oklahoma:** Beckham, Bryan, and Harmon

**Triggering Disaster 4:** Drought (Fast-Track) occurring September 10, 2024, and continuing.

**Application Deadline:** July 7, 2025

**Primary Counties Eligible:** Delta, Dickens, Franklin, Hopkins, and Jack

**Contiguous Counties Also Eligible:**

**Triggering Disaster 5:** Drought (Fast-Track) occurring September 17, 2024, and continuing.

**Application Deadline:** July 14, 2025

**Primary Counties Eligible:** Hunt, Rains, and Wood

**Contiguous Counties Also Eligible:** Camp, Collin, Delta, Fannin, Franklin, Hopkins, Kaufman, Rockwall, Smith, Upshur, and Van Zandt

**Triggering Disaster 6:** Drought (Fast-Track) occurring September 24, 2024, and continuing.

**Application Deadline:** July 18, 2025

**Primary Counties Eligible:** Smith and Van Zandt

**Contiguous Counties Also Eligible:** Cherokee, Gregg, Henderson, Hunt, Kaufman, Rains, Rusk, Upshur, and Wood
