## USDA Designates Two Pennsylvania Counties as Primary Natural Disaster Areas

Emergency Support to Producers in Surrounding Counties/Border State Also Available

**WASHINGTON, Sept. 10, 2019** — Agriculture Secretary Sonny Perdue designated two Pennsylvania counties as primary natural disaster areas. Producers in Lackawanna and Wayne counties who suffered losses due to excessive rain, flash flooding, and flooding that occurred July 21, 2018, through Feb. 28, 2019, may be eligible for U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) emergency loans.

This natural disaster designation allows FSA to extend much-needed emergency credit to producers recovering from natural disasters. Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation or the refinance of certain debts.

Producers in the contiguous Pennsylvania counties of Luzerne, Monroe, Pike, Susquehanna, and Wyoming, along with Broome, Delaware, and Sullivan counties in New York, are also eligible to apply for emergency loans.

The deadline to apply for these emergency loans is April 29, 2020.

FSA will review the loans based on the extent of losses, security available and repayment ability.

FSA has a variety of additional programs to help farmers recover from the impacts of this disaster. FSA programs that do not require a disaster declaration include: <a href="Emergency Assistance for Livestock">Emergency Assistance for Livestock</a>, <a href="Honeybees and Farm-Raised Fish Program">Honeybees and Farm-Raised Fish Program</a>; <a href="Emergency Conservation Program">Emergency Conservation Program</a>; <a href="Livestock Forage">Livestock Forage</a></a> <a href="Disaster Program">Disaster Program</a>; <a href="Livestock Indemnity Program">Livestock Indemnity Program</a>; <a href="Operating and Farm Ownership Loans">Operating and Farm Ownership Loans</a>; and the <a href="Tree">Tree</a> <a href="Assistance Program">Assistance Program</a>.
