## USDA Invests \$4.7 Million to Provide Outreach and Technical Assistance to Historically Underserved Farmers and Ranchers

Four Organizations Identified to Assist Producers in California

The U.S. Department of Agriculture (USDA) announced an investment of \$4.7 million to establish partnerships with organizations to provide outreach and technical assistance to historically underserved farmers and ranchers. The partnerships will support participation in Farm Service Agency (FSA) programs, including those that are part of USDA's <a href="Pandemic Assistance for Producers">Producers</a> initiative. ? ?

Fifty-six project proposals, covering all states and territories, are being finalized to assist historically underserved farmers and ranchers in accessing FSA programs. Programs include outreach for pandemic assistance programs. These proposals will also assist in outreach for FSA's farm programs, conservation programs, farm loans, county committee elections, disaster programs, the Heirs' Property Relending Program, heirs' property succession planning and the Agricultural Marketing Service's Pandemic Response and Safety Grant program.

"Of the 56 selected proposals, four will directly impact farmers and ranchers in California," said Jacque Johnson, Acting State Executive Director for FSA in California. "These partnerships will provide important technical assistance, outreach and education and will equip farmers and ranchers with the resources needed to access and participate in FSA's programs and services."

The organizations and projects impacting California include:

- California Farmlink providing support on Operating and Farm Ownership Loans in North Coast,
   Central Coast and Sacramento area.
- California State University Fresno Foundation Inc. providing support on the Tree Assistance Program, ARC-PLC, Emergency Livestock Assistance Program and Farm Registrations in Fresno, Kern, Kings, Merced, Madera, San Joaquin, Stanislaus and Tulare counties.

- Interfaith Sustainable Food System Collaborative providing support for FSA disaster programs in Alameda, Contra Costa, Sonoma, San Francisco and Marin counties.
- National Women in Agriculture Association: California Chapter providing support in Farm Ownership, other FSA programs and AMS's Pandemic Response and Safety Grant in San Diego, Humboldt, Los Angeles, Alameda and Fresno counties.
