Biden Administration Appoints William Bunce to Serve as State Executive Director for USDA's Farm Service Agency in Wyoming

WASHINGTON, Dec. 6, 2022— The Biden Administration recently appointed William ‘Bill’ Bunce as the new State Executive Director (SED) for the USDA Wyoming Farm Service Agency (FSA).

“Individuals selected to serve as FSA State Executive Directors are incredible public servants who have a proven track record when it comes to their commitment to advance their states and communities,” said Agriculture Secretary Tom Vilsack. “Each will serve on the frontlines, carrying out USDA’s mission at the state level and ensuring the voice of each and every USDA customer is heard. We are fortunate to have each of these talented individuals at this critical time for farmers and producers and rural communities across America.”

Bunce brings decades of agriculture production and agribusiness experience to USDA’s FSA, having managed multiple large-scale Wyoming ranches, including livestock, sheep, and cattle feedlot operations.

A graduate of the University of Missouri, Bunce’s career has spanned ranch management, agribusiness, and livestock breed association management, including service as senior operational management with the American Quarter Horse Association, the Quarter Horse Journal, and the Quarter Racing Journal.

He has also served as the Vice President of the American Polled Hereford Association and as the Executive Director of the New Mexico Livestock Board. Bunce served the State of Wyoming as the Marketing Director for the Wyoming Department of Agriculture and was a staff director for the Wyoming Business Council.

As SED, Bunce will be responsible for overseeing the delivery of FSA programs to agricultural producers in Wyoming. These commodity, conservation, credit, and disaster assistance programs ensure a safe, affordable, abundant, and nutritious food, fiber, and fuel supply for consumers.

“The State Executive Director is a pivotal leadership position for the Agency and for the agricultural producers we serve,” said Marcus Graham, FSA Deputy Administrator for Field Operations. “These leaders, appointed by the Biden-Harris Administration, bring a wealth of knowledge and expertise to their respective states. We are happy to have them on board and wish them much success.”
