## Federal Emergency Management Agency Designates 23 Texas Counties as Primary Natural Disaster Areas Due to Qualifying Winter Storms

### ***Includes Declaration Amendments Making More Counties Eligible for Assistance***

This Presidential disaster declaration allows the United States Department of Agriculture (USDA) Farm Service Agency (FSA) to extend much-needed emergency credit to producers recovering from natural disasters through [emergency loans](#). Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation, or to refinance certain debts. FSA will review the loans based on the extent of losses, security available, and repayment ability.

**Impacted Area:** Texas

**Triggering Disaster #1:** Severe Winter Storm

**Application Deadline:** December 21, 2023

**Primary Counties Eligible:** Bastrop, Blanco, Burleson, Burnet, Hays, Henderson, Kendall, Lee, Leon, Milam, Robertson, Travis, and Williamson

**Contiguous Counties Also Eligible:** Anderson, Bandera, Bell, Bexar, Brazos, Caldwell, Cherokee, Comal, Ellis, Falls, Fayette, Freestone, Gillespie, Guadalupe, Houston, Kaufman, Kerr, Lampasas, Limestone, Llano, Madison, Navarro, San Saba, Smith, Van Zandt, and Washington

**Disaster 1, Amendment 1:** Severe Winter Storm

**Application Deadline:** January 8, 2024

**Primary Counties Eligible:** Anderson, Falls, Gillespie, Hopkins, Kerr, Kimble, Limestone, and Red River

**Contiguous Counties Also Eligible:** Bandera, Bell, Blanco, Bowie, Cherokee, Delta, Edwards, Franklin, Freestone, Henderson, Hill, Houston, Hunt, Kendall, Lamar, Leon, Llano, McLennan, Mason, Menard, Milam, Morrie, Navarro, Rains, Real, Robertson, Schleicher, Sutton, Titus, and Wood.

**Oklahoma:** Choctaw and McCurtain

**Disaster 1, Amendment 2:** Severe Winter Storm

**Application Deadline:** January 22, 2024

**Primary Counties Eligible:** Franklin

**Contiguous Counties Also Eligible:** Camp, Delta, Hopkin, Red River, Titus, and Wood

**Disaster 1, Amendment 4:** Severe Winter Storm

**Application Deadline:** March 1, 2024

**Primary Counties Eligible:** Comal

**Contiguous Counties Also Eligible:** Bexar, Blanco, Guadalupe, Hays and Kendall
